SUMNER COUNTY NOTARY PUBLIC APPLICATION

This application must be signed under oath in the presence of a notary public and submitted to the County Clerk's office 12:00 noon prior to the meeting of the county legislative body at which it is to be considered. You will receive a letter of confirmation after your election. Each elected Notary will be required to post a \$10,000 surety bond. The bond must be filed in the office of the County Clerk, who will accept the \$12.00 fee and administer the oath of office. You are not authorized to act as a notary public until you have received your commission from the Governor. If you move your residence or your principal place of business out of this county, you are required by law to notify the County Clerk of the change of address.
