THIS APPLICATION, WHEN DULY EXECUTED IN FRONT OF A NOTARY AND SIGNED BY ONE RECOMMENDING COUNTY COMMISSIONER OF HUMPHREYS COUNTY, MUST BE SUBMITTED TO THE COUNTY CLERK AT LEAST TEN (10) DAYS PRIOR TO THE MEETING OF THE COMMISSION. IF ELECTED, YOU MUST MAKE BOND IN THE AMOUNT OF \$10,000.00 PAYABLE TO THE STATE OF TENNESSEE AND CONDITIONED UPON THE FAITHFUL PERFORMANCE OF THE DUTIES OF NOTARY PUBLIC. SUCH BOND MUST BE FILED IN THE OFFICE OF THE COUNTY CLERK, WHO WILL ADMINISTER THE OATH OF OFFICE AND ACCEPT THE REQUIRED FEE. THE GOVERNOR WILL THEN COMMISSION YOU A NOTARY. SUCH COMMISSION EXPIRES FOUR (4) YEARS AFTER ISSUANCE.
