## **MONTGOMERY COUNTY NOTARY PUBLIC APPLICATION**

This application must be signed under oath in the presence of a notary public and submitted to the County Clerk on or before the last day of the month. You must then be commissioned by the Governor. You will be required to post a bond in the amount of Ten Thousand Dollars (\$10,000) and it must have specific effective dates which may be obtained from our office or online at <a href="https://www.mcclerktn.org">www.mcclerktn.org</a>. The bond must accompany the application when submitted to the office of the County Clerk, who will accept the required fees and administer the oath of office. You are not authorized to act as a notary public until you have received your commission from the Governor, filed your bond, and taken the oath of office. If you move your residence or your principal place of business out of this county, you are required by law to notify the County Clerk of this county of your change of address.
