SUMNER COUNTY NOTARY PUBLIC APPLICATION

This applicant must sign under oath (We can notarize your form in our office) and submit to the County Clerk's office 12:00 noon prior to the meeting of the County Legislative Body at which it is to be considered. You are required to appear in the Clerk's office to take the oath and pay a \$12.00 fee. At that time, you are required to post a \$10,000 surety bond. You are not authorized to act as a Notary Public until you have received your commission from the Governor. If you move your residence or your principal place of business out of this county, you are required by law to notify the County Clerk of the change of address.
